# HSBC Euro ESG Liquidity Fund

# Investment objective

The Fund aims to provide security of capital, daily liquidity and an investment return that is similar to Euro denominated money markets interest rates while considering select environmental, social and governance (ESG) criteria. The Fund is classified as an Article 8 Fund under SFDR.



# Investment strategy

The Fund is actively managed.

The Fund will invest in a diversified portfolio of short-term securities, instruments and obligations. These instruments will be short-term fixed or floating-rate securities that mature in 397 days or less. They will be issued by companies, governments and government-related entities and either listed or traded on a Recognised Market.

The Fund's investments will typically have a credit rating of least A-1 or P-1 (or its equivalent) from a recognised credit rating agency.

The Fund can invest in a range of short-term securities, instruments and obligations.

The Fund's liquidity is daily – meaning investors can redeem their investment on any business day.

The Fund is classified as a Low Volatility NAV Money Market Fund under the European Union Money Market Fund Regulations.

The Fund's primary currency exposure is to Euro.

The Fund does not have a specific sustainable investment objective, although shall seek to identify issuers that are better at addressing ESG risks, and assign ESG scores and screens to create a 'best in class' universe of issuers.

#### Main risks

- The Fund's unit value can go up as well as down, and any capital invested in the Fund may be at risk




